

**QANTAS WIN FUEL FOR A YEAR
COMPETITION TERMS & CONDITIONS**

1. Information on how to enter forms part of the terms and conditions of entry. Entry into the promotion is deemed acceptance of these terms and conditions.
2. The promoter is Qantas Airways Limited (ABN 16 009 661 901) of 203 Coward Street, Mascot, NSW, Australia 2020 (telephone number 13 31 13) (**Promoter**).
3. The promotion commences at 12:01am AEST on 8 October 2010 and closes at 11:59pm AEST on 30 November 2010 (**Promotion Period**).
4. Entry is open only to Australian resident members of the Qantas Frequent Flyer program, who have linked their membership to Woolworths Everyday Rewards and swapped fuel savings for Qantas Frequent Flyer points at everydayrewards.com.au (**Eligible Entrants**), excluding officers, management, employees and their immediate families of the Promoter and its related bodies corporate and excluding members whose Qantas Frequent Flyer account is suspended, cancelled or otherwise terminated at any time during the Promotion Period or at the time of a prize draw. Eligible Entrants who are under 18 years of age must have approval from their parent or guardian to enter the promotion.

The Petrol Gift Cards can be redeemed at Caltex Woolworths/Safeway co-branded fuel outlets. Petrol Gift Cards are valid for 12 months from their date of issue and are subject to terms and conditions which can be found at wishgiftcard.com.au. The maximum total prize value is \$12,500.
